1. Apologies for Absence

There were no absences.

2. Receive, approve and sign the Minutes of the Ordinary Meeting of the Parish Council (no SPC/TF/078) held on Monday 6th July 2015.

The minutes were signed by the Chairman as a correct record of the meeting

3. Declarations of Interest

The Parish Clerk reminded Councillors of the need to ensure that they declare all disclosable pecuniary interest and all non – disclosable pecuniary interests and that the onus was on Councillors to declare their interest at the appropriate time.

There were no declarations of interest by members in respect of items on the agenda, and no requests for new Disclosable Pecuniary Interest dispensations were received.

4. Report from Clerk on actions from the last meeting There were thirteen actions requiring completion, two was completed, and ten were in progress and one closed. (Appendix 1 refers)

5. Questions/Issues on any matter, from members of the public present. 5.1 Ward Councillors Report

Cllr Guthrie gave a verbal report to the Parish Council (Appendix 2 refers)

5.2 Local Police Report

The August 2015 Newsletter had been circulated to Councillors and put on the village website. Its contents were noted.

5.3 Questions from other members of the public

There were no questions from the public.

(Agenda item 7 - Footpaths in the Village was considered at this point)

6. Upgrade Bins

The Parish Council was informed there was a standard bin and that Herefordshire Council had been asked for clarification and whether these have to be purchased from Balfour Beatty.

The Parish Council considered whether to have collections by a local contractor (chargeable to the Lengthsman Scheme) on non –refuse collection days and store refuse in a Trade Waste Bin at the Village Hall. The Parish Council would like to get this sorted at its next meeting. Having considered the matter and to clarify the matter the Parish Council Resolved that:

- The Bins at the Lichgate on the Rhea and at the Old Post Office be replaced. At a cost to the Parish Council
- An additional bin be purchased to replace the one missing at the Playing field.at a cost to the Parish Council
- An addition bin be purchased and located at the entrance to the footpath at Ordis Farm. (Across from the Grit Bin). At a cost to the Parish Council.
- The cost to the Parish Council for the additional collection from Ordis Farm be sort.

Action- Clerk to inform Herefordshire Council of the Parish Council decision, requesting the bin specification and cost of supplying the additional bins and that the cost of the collection from Ordis Farm.

7. Footpaths in the village

The Footpath Officer gave a verbal report (Appendix 3 refers), which was noted by the Parish Council. The Parish Council thanked Mike Darley for his report and congratulated him on becoming an Associate of the Institute of Public Rights Of Way Access & Management.

8. Planning Applications

To consider the following applications:-

 The Pastimes, Old School Close, Sutton St. Nicholas, Hereford HR1 3DH (151943) – (Retrospective) Garage and store to side of house, single storey. Having considered the matter the Parish Council Resolved that it was in favour of the changes made to the pitch of the roof.

9. Nuisance Bonfires

The Parish Council considered the matter of nuisance bonfire, mention was made of the recent incident when smoke from a bonfire triggered the fire alarm at the telephone exchange. Having considered the matter including information from Herefordshire and the National Society for Clean Air and Environmental Protection the Clerk was asked to put an article in the Sutton News highlighting the issues of air pollution, health effects and annoyance impact.

Action – Clerk to put an article in the Sutton News.

10. Transfer of open spaces

This is a standing agenda item and currently there was no update to report.

11. Neighbourhood Plan

Councillor Richard Andrews declared a Non- Disclosable Pecuniary interest and took no part in discussions. The Parish Council was informed that following the Fete the project group met on 16th July and agreed the land for potential development. The Parish Council was also informed that of those who commented at the Fete 83% were in favour of the land identified for development.

The Clerk informed the Parish Council that he will be meeting with a contractor on Tuesday evening 4th August for a site visit, and that it was hoped that a decision could be made at the next meeting.

17. Wellbeing innovation Grant Scheme

The Parish Council was informed that Cllr Toon had forwarded to the Clerk information related to this scheme, which offers grants of between £5k and £20k for projects that aim to improve people's health and quality of life particularly those who are vulnerable at risk of social isolation or loneliness. It was felt that this scheme could be linked to the Good Neighbour scheme.

Ward Councillor's report

Update on Highways Issues

C1126 Flooding Issue (Near St. Michaels Church)

This issue is being addressed by Balfour Beatty & therefore, there is now no longer a need for a site visit at the moment.

C1126 – Balfour Beatty Repair Works – will be investigated by Sean Rooney (Interim Head of Highways). I will contact him regarding the issues & concerns regarding the "failed works".

C1120 Further request for resurfacing response from Balfour Beatty as follows:

"The C1120 Moreton Bridge to Marden. Routine gangs carried out some work there but no resurfacing works have been carried out and we do not have any resurfacing works programmed for this. The asset management team have reviewed the survey data and this road does not meet the criteria for work at the moment. When new data comes in the road will be assessed again against all the other roads in the County".

I will further contact Balfour Beatty and request a copy of the C1120 Assessment Report – for information accordingly.

Herefordshire Council – Budget Consultation

"Priorities and budget consultation 2016 to 2020 – Have Your Say" Visit Herefordshire Council's website & take part in the consultation which runs from 24th July to 9th October 2015.

"As a result of substantial government funding reductions, we need to significantly reduce our budget and make unprecedented changes to our services. It is estimated that we will need to save an additional £42 million during this year and the next four financial years. We would like your help in deciding our priorities and how to spend our budget"

Bus Services

Update from Alan Lewis (Public Transport Manager)

"I can now advise that following discussions we have received bus service registrations to provide continuation of First Hereford routes from 6th September. Yeomans Canyon Travel will be providing Hereford area services both commercial and subsidised at similar times to the existing First journeys. DRM will be covering journeys on service 420 Hereford – Bromyard – Worcester."

Problems with HGV & Agricultural traffic in the Ward area

I have arranged site visits at Moreton Bridge & Laystone Bridge with BBLP to further discuss how best to protect the bridges.

Speed Enforcement - Update

Special constables have carried out speed checks in Marden & Sutton (no one was encountered speeding, at the time of the checks). The speed checks in these areas will continue over the forthcoming weeks.

Speeding Traffic Enforcement – Community Speedwatch

For consideration of the Parish Council – Bob Haynes (Police Traffic Manager) has advised that the Safer Roads Partnership would need 6 volunteers to train up for Community Speedwatch to be

progressed (with the possibility of borrowing the speed gun from Marden PC) who already have Community Speedwatch.

Footpaths Officers Report

Harvest is upon us once again and as fast as the cropping and ploughing issues arise, they have disappeared,(ST 3 Freens Court)

The majority of paths are in a very good state of repair with the usual few that need to be cut, ST 2, ST 3, ST 9, ST 12, ST 13 & ST14 from the gas station. This will be the final round of cuts, making it a full width trim.

During September, various walking groups will be using our paths, which is a tribute to the way they have been managed and kept open for users of all ages and abilities.

Over the Winter months, ST 15 will see some improvements made to it, with a widening programme and top surface clean up and holes filled in, that were caused by the 4X4's.

Some trees that are still down, will be finally removed. (ST 2, ST14 & ST15)

The maintenance plan for 2016 is underway and will no doubt see further improvements in the Parish.

One final note, I'm happy to announce that I have been accepted to the Institute of Public Rights Of Way access & management as an Associate member. This will allow me to access more solid information on laws and Legislation.
